HSTAG Input

- April 17, 2018 HSTAG meeting
 - Discussed scope and priorities of \$1M study
 - Discussed how to integrate public input
- August 7, 2018
 - Draft RFP sent to HSTAG for input
- August 8, 2018
 - City, County and State reached settlement with SoCalGas providing \$25 million toward health study
- September 10, 2018
 - HSTAG members polled on revising scope of \$1M health study given the \$25M allocated from the other settlement
 - Majority of HSTAG members supported revised scope

Draft RFP for \$1M Study

- Revised Scope: Data Integration and Exposure Modeling
 - May include additional environmental sampling to inform a more robust model
- Lays the CRITICAL and NECESSARY foundation for any health studies of the impacts of this incident
- Timing of this work complements the \$25M health study timing

Draft RFP Features (Page 1 of 2)

Input from HSTAG, Public	How this is being addressed
Screen for potential conflicts of interest	Conflict of Interest form required and part of proposal consideration (Attachment A, and Sections 8 and 10)
Use the full \$1M completely	Proposal scoring points weighted to emphasize Technical elements rather than cost (Section 10)
Sufficient community involvement/engage ment in study	Requires Outreach Plan (Section 8), and proposal scoring points includes points for ensuring community engagement (Section 10)

Draft RFP Features (Page 2 of 2)

Input from HSTAG, Public	How this is being addressed
Allow data from this study to inform potential future studies	Requires final exposure model and data to be publicly shared (Section 5)
Allow investigators from far-away places to apply	Allows for a wide range of investigators (Section 7)
Specific suggestions for clinical testing	No need to be prescriptive about the type of testing in this RFP, but rather, Section 5 allows for a range of possibilities
Areas of health concern, use of comparison group	These would pertain to the \$25M study by DPH
