










SUMMARY OF OVER 2 YEARS OF MEASUREMENTS NEAR OIL WELLS

Area D

- ~ 300 active oil wells
- 2 locations with elevated VOC concentrations
 - I location with persistent elevated VOCs*

Area E

- ~ 160 active oil wells
- I location with elevated VOC concentrations#
 - 0 locations with persistent elevated VOCs*

Area F

- ~ 75 active oil wells
- 3 locations with elevated VOC concentrations
 - 3 locations with persistent elevated VOCs*

^{*}Emissions from different components and/or other sources may have been responsible for elevated levels of VOCs measured during different measurement days #Area E was at an industrial location, far from the community











INSPECTION TYPES

Two Types of Inspections

- Staff-Initiated
 - Unannounced Facility Inspections
 - Focused Inspections based on Rule or Process
 - CERP commitments (e.g., inspections initiated by Monitoring efforts)
- Response-Based
 - Public complaints
 - Notifications from the facility
 - Referrals from government agencies



Statistics included in this enforcement update focus on staff-initiated inspections


CERP commitment: If persistent elevated levels are detected at locations through air measurement activities, conduct follow-up investigations at those locations using appropriate field measurement equipment

- As a result of Mobile Monitoring efforts, Inspectors followed-up at 36 facilities
- The CSC was updated on those findings in October 2019, May and November 2021, and February 2022.



OIL AND GAS IMPLEMENTATION (CON'T)



- Since July 2019, inspectors have conducted over 265 staff-initiated inspections within WCWLB at crude oil and oil terminal facilities
- Approximately 60 of which resulted in enforcement actions

LEAK DETECTION AND REPAIR (LDAR)



Detection

Possible ways to observe an emission leak at an oil & gas production facility

Olfactory

(e.g., rotten egg, gaseous odors)

Optical Gas
Imaging
Cameras

Liquid Leaks Handheld Hydrocarbon Monitors

Repair



If facility detects a leak, Rule 1173 sets repair period based on leak size

If our inspectors detect a leak, NOV or NC will be issued based on leak size, with applicable repair period



IDLING RESTRICTIONS

I. Without a "Certified Clean Idle" sticker, no idling <u>anywhere</u> for over <u>five minutes.</u>


2. Even with a "Certified Clean Idle" sticker, special prohibition on idling within 100 feet of schools, residences, hotels, or other restricted areas for more than five minutes.



3. Diesel-fueled auxiliary power systems (APS) also may not be operated for over five minutes within 100 feet of any restricted area.

THE QUEUEING EXCEPTION

- "Queuing" refers to waiting to perform work in a line of vehicles that is repeatedly starting and stopping, when shutting off the vehicles' engines is not possible.
- Does not include waiting in line before the start of a workday or the opening of a work location.





IDLING TRUCK IMPLEMENTATION



CERP Commitment: Conduct, at minimum, quarterly idling sweeps and focused inspections for one calendar year, to be evaluated thereafter with community input.
