Inabinet **Telephone Number:** (909) 396-2453 South Coast Air Quality Management District area of jurisdiction: South Coast Air Basin **Project Location:** (all of Orange County and the nondesert portions of Los Angeles, Riverside, and San Bernardino counties), and the Riverside County portions of the Salton Sea Air Basin and Mojave Desert Air Basin. **Project Description:** PAR 1112.1 contains the following four amendments: 1) change the CO emissions limit from cement kilns to 1,900 ppm from the previous limit of 2,000 ppm and change the averaging time to an eight hour period in lieu of complying with the Rule 407 (a)(1) averaging time, which is based on a 15 minute averaging period; 2) require a Continuous Emissions Monitoring System (CEMS) to be installed by December 31, 2009 on cement kilns for CO and oxygen monitoring and operated in accordance with Rule 218; 3) conduct CEMS certification tests and other sampling, analysis, and reporting by an approved laboratory; and 4) add test methods and approved equivalents for determining CO and PM emissions levels. Only one facility, California Portland Cement Company (CPCC), located at 695 South Rancho Avenue in Colton, California, will be affected by PAR 1112.1. The environmental analysis in the Draft EA concluded that PAR 1112.1 would not generate any significant adverse environmental impacts. This is to advise that the South Coast Air Quality Management District has approved the above described project and has made the following determinations regarding the above described project: 1. The project will not have a significant impact on the environment. 2. Mitigation measures were not made a condition of the approval of this project. 3. A mitigation monitoring program under PRC § 21081.6 was not adopted for this project. 4. A Statement of Findings was not adopted for this project. 5. A Statement of Overriding Considerations was not adopted for this project.
