- Project Location: WTU Central Facility is located at 625 E. Anaheim St., Wilmington, California 90744
- **Project Description**: At its oil production facility at the Wilmington Townlot Unit (WTU) Central Facility, Warren E&P is proposing to remove the existing permitted Flare King flare and replace it with an ultra-low NO<sub>x</sub> Bekaert Clean Enclosed Burner® (Bekaert CEB®), refurbish existing Heater-Treater No. 1 (HT#1) and add an additional heater-treater (HT#2) with ultra-low NO<sub>x</sub> burners to meet oil-water separation needs, add up to nine Ingersoll-Rand MT-70 microturbines to generate electrical power for use on site, and remove a previously-operated water heater. In addition, Warren E&P is proposing to install gas re-injection equipment to reduce the need to combust excess gas production and, if warranted, gas sales equipment. The Bekaert CEB® and HT#2 meet the SCAQMD's best available control technology requirements. The proposed project does not include previous construction activities or previously permitted operations.

This is to advise that the *South Coast Air Quality Management District* has approved the above described project and has made the following determinations regarding the above described project:

- 1. The Final SMND was prepared for this project pursuant to the provisions of CEQA.
- 2. The proposed project has potential significant adverse impacts on the environment.
- 3. Mitigation measures were made a condition of the approval of this project that reduced the potential environmental impacts to less than significant.
- 4. A mitigation monitoring and reporting plan under PRC Section 21081.6 was adopted for this project.
- 5. A Statement of Overriding Considerations was not adopted for this project because the potential environmental impacts were not significant.
- 6. Findings were not made pursuant to the provisions of CEQA.
