Project Location: The SCAOMD has jurisdiction over all of Orange County, the urban portions of Los Angeles and San Bernardino counties southwest of the San Bernardino and San Gabriel mountains, and nearly all of Riverside county, with the exception of communities near the state border. PAR 1110.2 would affect only one facility, MM PRIMA DESHECHA ENERGY, LLC, which is located at 32250 La Pata Ave, San Juan Capistrano, CA 92675.

Project Description: The proposed project consists of amending Rule 1110.2, which would provide a facility operator relief from the emissions requirements specified in Table III-B of Rule 1110.2, provided the facility has submitted a plan, approved by the Executive Officer, that commits the operator of this facility to inactivate permits and shut down and disable all equipment subject to Rule 1110.2 by October 1, 2022 in specified ways. PAR 1110.2 would affect only one facility, MM PRIMA DESHECHA ENERGY, LLC, which is located at 32250 La Pata Ave, San Juan Capistrano, CA 92675. The proposed project is a modification of a recent project (Final SEA for PAR 1110.2, certified on December 4, 2015), and this analysis considers only the incremental effects of the currently proposed project. Therefore, this Final SEA focuses on air quality as an environmental topic area that is adversely affected by the proposed project, as the proposed amendments do not affect any other environmental topic areas.

This is to advise that the SCAQMD has approved the above described project and has made the following determinations regarding the above described project:

- 1. The project will have a significant impact on the environment.
- 2. Since feasible mitigation measures to reduce impacts to less than significant were not identified for this project, mitigation measures were not made a condition of the approval of this project.
- 3. Since mitigation measures were not made a condition for approval of this project, a mitigation monitoring program under PRC § 21081.6 was not adopted for this project.
- 4. Findings pursuant to CEQA Guidelines §15091 were adopted for this project.
- 5. A Statement of Overriding Considerations pursuant to CEQA Guidelines §15093 was adopted for this project.
