Environmental Justice Conference Engages Community

On December 2, 2017, SCAQMD hosted its third annual conference, “A Conversation on Environmental Justice.” The conference is part of SCAQMD’s comprehensive Environmental Justice Community Partnership program, which aims to strengthen the Agency’s relationship with stakeholders in environmental justice communities. Local residents, environmental justice leaders, academics, business owners, elected officials, and other members of the community attended the free event and participated in a variety of breakout discussions. Panels addressed current issues affecting local environmental justice communities.

The Environmental Justice Community Partnership was established in February 2015 by SCAQMD Chairman Dr. William A. Burke. Through this grassroots partnership, SCAQMD hosts a series of events with a special focus on environmental justice. Forums, training sessions and other engaging outreach activities help broaden mutual awareness of environmental justice topics, and keep SCAQMD connected to the residents whom the agency serves.

This year’s conference offered panels on issues such as innovations in zero-emissions technologies;

best practices for cooperative action among community stakeholders, local agencies, governments, and businesses; strategies for grant-writing and finding local funding; and current responses to public health challenges faced by EJ communities. Wayne Nastri, Executive Officer of the SCAQMD, led an afternoon plenary session on recent policy actions in environmental legislation, and what those actions mean for EJ communities. Los Angeles City Council President Herb J. Wesson, Jr. delivered the conference’s keynote address. Board Approves \$27.3 Million to Replace Diesel Engines with Cleaner Models

On November 3, 2017, the SCAQMD Governing Board approved executing contracts for eligible projects under the “Year 19” Carl Moyer Program and SOON Provision, for an amount of nearly \$28 million. The awarded funds will be used for on- and off-road and marine engine replacement and repower projects. All eligible on-road heavy-duty vehicle projects were recommended for awards to encourage more applicants in this category and to facilitate a more rapid turnover in the existing fleet. Over 56-percent of the projects are located in disproportionately impacted areas and communities.

The Board also approved executing contracts for additional projects meeting the Carl Moyer Program criteria for approximately \$51 million contingent upon funds being allocated by the California Air Resources Board to the SCAQMD under AB 134. Total annual NOx and PM emissions reductions for all of the awarded projects are approximately 419 tons and 23.6 tons, respectively.

Additionally, the Board approved the transfer of \$2 million from the Carl Moyer Program AB 923 fund to the Voucher Incentive Program to continue funding truck replacement programs.

SCAQMD Scientists Begin Fifth MATES Study

The fifth Multiple Air Toxics Exposure Study (MATES V), scheduled to begin this month, will continue to investigate airborne toxic compounds within our basin and their associated cancer risks. This unique study will have two components; the traditional fixed site monitoring and a new enhanced monitoring effort. The fixed site monitoring stations will continue to characterize long-term regional air toxics levels in residential and commercial areas over a one-year period at ten locations throughout the Basin. Measurements will include many air toxic compounds as well as ultrafine particles and black carbon. Air toxics modeling and SCAQMD's emissions inventory will be later utilized to quantify health impacts as previous MATES studies. To complement the fixed site monitoring, the enhanced monitoring effort will apply advanced state-of-the-art remote sensing technologies, low-cost sensor networks, and near real-time data and community engagement to conduct enhanced air toxics monitoring at local scales with a focus on highly impacted communities, especially those near refineries. This information will provide higher resolution air quality data to better estimate emissions and their subsequent health impacts.

2018 Compliance Deadlines

The following is a reminder of upcoming SCAQMD compliance deadlines. This is a reference SCAQMD provides annually through the SCAQMD Advisor and is subject to change. New rules and regulations may be adopted and current rules may be amended or rescinded throughout the year. Such decisions may impact your business.

Manufacturers/Suppliers/Installers of Condensing, Non-condensing, and Mobile Home Furnaces

The extension for complying through a 36-month mitigation fee will end on March 30, 2018, for condensing units and end on September 30, 2018, for non-condensing units. After these dates condensing and non-condensing units must comply with the nitrogen oxides (NO_x) emission limit of 14 nanograms/joule (ng/J) of heat input.

Mobile home furnaces must comply with the NO_x emission limits of 14 ng/J of heat input by October 1, 2018. The manufacturer may elect to pay a per unit mitigation fee of \$150 for up to 36 months for each mobile home furnace in lieu of meeting the NO_x emission limit. For each 12-month time period, the manufacturer is required to submit an alternate compliance plan. Please refer to Rule 1111 to learn more about the alternate compliance plan.

It is important to note that staff is recommending an extension to all of the above mentioned compliance dates in a proposed amendment to Rule 1111. The proposed amendment will be presented at a Public hearing prior to the April 1, 2018, compliance date.

Landfill and Biogas Engine Operators

Effective January 2, 2018, The City of San Bernardino, Orange County Sanitation District, and Eastern Municipal Water District commenced and implemented technology demonstration projects prior to January 1, 2015. All their biogas engines shall comply with the requirements of Table III-B of Rule 1110.2.

Expiration of Small Container Exemption

Effective January 1, 2018, Tub and Tile Refinishing Coatings; Clear and Pigmented Shellacs; and Reactive Penetrating Sealers sold in containers of one liter (1.057 quart) or less must comply with the provisions of the Table of Standards 1 and paragraph (c)(1) of Rule 1113.

Refinery Flares

Effective January 30, 2019, general service flares at petroleum refineries shall maintain the net heating value of the flare combustion zone gas (NHV_{cz}) at or above 270 British Thermal Units per standard cubic feet, averaged over a 15-minute period.

Effective January 30, 2019, conduct a Specific Cause Analysis for any flare event at a petroleum refinery when the smokeless capacity of the flare is exceeded.

Effective January 30, 2019, no flare event at a petroleum refinery shall occur above the smokeless capacity of the flare under the certain conditions.

Effective January 30, 2019, monitor all flares for visible emissions using color video monitors with date and time stamp, capable of recording a digital image of the flare, the flame of flares that are not enclosed, and a sufficient area above the flame of all flares that is suitable for visible emissions observations, at a rate of no less than one frame every 15 seconds.

NO_x Reduction from Miscellaneous Sources

All ovens, dryers, dehydrators, heaters, kilns, calciners, furnaces, crematories, incinerators, heated pots, cookers, roasters, fryers, heated tanks, evaporators, distillation units, afterburners, degassing units, vapor incinerators, catalytic or thermal oxidizers, soil and water remediation units, and other combustion equipment with NO_x emissions less than one pound per day that becomes 35 years old on or before July 1, 2018 shall demonstrate compliance with the applicable emission limit specified in paragraph (c)(1) of Rule 1147 on or before July 1, 2020.

NOx Emissions from Commercial Food Ovens

Griddle ovens and ovens used solely for making pita bread manufactured prior to 1999 are required to submit an air quality permit application by October 1, 2017. These businesses must meet the applicable emission limits specified on Table 1 of Rule 1153.1 by July 1, 2018.

In-use ovens, dryers, smokers, and dry roasters manufactured from 1992 through 1998 are required to submit an air quality permit application by October 1, 2018 and must meet the applicable emission limits specified on Table 1 of Rule 1153.1 by July 1, 2019.

Cement Manufacturing Facilities

For cement manufacturing operations, the ambient hexavalent chromium concentration threshold limit is 0.20 nanograms/cubic meter. Any exceedance that occurs after September 5, 2018 will be considered to be a violation of Rule 1156.

Liquefied Petroleum Gas (LPG) Dispensing and Transfer

By July 1 of each year from 2014 through 2018, the owner/operator of an LPG bulk loading facility shall submit to the Executive Officer an end of year inventory of all facility located containers, including all facility-owned or leased mobile fuelers associated with the transfer or storage of LPG that are equipped with one or more fixed liquid level gauges (FLLG) for the prior calendar year.

Lead Emissions from Metal Melting Facilities

Beginning April 1, 2018, lead metal melting facilities shall not discharge emissions into the atmosphere which contribute to ambient air concentrations of lead that exceed 0.100 µg/m³. Refer to Rule 1420.2 for compliance, monitoring and sampling requirements.

SCAQMD Adopts Rule to Reduce Odors from Rendering Plants

For years, the South Coast region's five rendering plants in Vernon negatively impacted the quality of life for residents living in nearby environmental justice communities with their periodic strong odors. However, residents can now breathe easier: this past November, SCAQMD adopted a new regulation aimed at reducing odors from these rendering plants.

Rendering plants take animal parts and carcasses from livestock slaughter, poultry and meat packing operations, butcher shops and grocery stores and turn them into materials that are used to produce consumer products such as soap, cosmetics and pet food. SCAQMD already requires control of high-intensity odors from cookers at the plants. However, animal parts and carcasses that are handled and processed outdoors and wastewater treatment systems cause a distinct pungent odor that can drift for miles and cause headaches, nausea and respiratory irritation, impacting surrounding communities.

Following November's rule adoption, rendering facilities will be

required to conduct housekeeping practices, including covering incoming trucks, washing out trucks before they leave the plant, limiting the time animal materials are allowed to remain outdoors, repairing cracks and holes in outdoor asphalt and concrete areas that can accumulate liquid materials, and other measures within 90 days. Within no more than 3½ years, the rendering plants will have to install either a total enclosure or a closed system for certain processes to keep odors from drifting out of their buildings and into the community.

As an added safeguard to the community, if SCAQMD issues a Notice of Violation to a facility for odors, or confirms three or more odor events within 180 days, the facility will have to submit an odor mitigation plan and take steps above and beyond rule requirements to minimize odors. Each facility also will have to post visible signs with SCAQMD's 24-hour air pollution complaint hotline, 1-800-CUT-SMOG.

SCAQMD Requires Fenceline and Community Air Monitoring for Refineries

On December 1, the SCAQMD Governing Board adopted Rule 1180 – Refinery Fenceline and Community Air Monitoring and Guidelines. This new rule applies to the region's eight major oil refining facilities to provide the public with real-time, fenceline air monitoring data by 2020. The refineries will provide funding to SCAQMD to establish and operate air monitoring systems in communities near their facilities.

"Fenceline air monitoring data can provide information to residents and agencies about routine emissions as well as accidental releases," said Wayne Nastri, SCAQMD's executive officer. "It also can help quickly identify sources of leaks which will lead to further emission reductions at refineries."

Pollutants to be monitored include smog-forming nitrogen and sulfur oxides as well as toxic compounds such as benzene, toluene and hydrogen cyanide. Refineries also will have to monitor for the highly toxic compound hydrogen fluoride, if used at the facility.

Refineries will make their fenceline monitoring data available to the public via a website or other electronic means, and implement a public outreach program explaining the readings.

The work on this ground-breaking rule began last Spring and additional concepts were incorporated after the California Legislature passed and the Governor signed into law AB1647 this Fall.

2017 Smog Season Recap

For the second year in a row, the South Coast Air Basin concluded the smog season with an increase in ozone standard exceedance days compared to the all-time low of the prior years. The smog season had a total of 145 days that exceeded the 2015 federal 8-hour ozone standard which has been the greatest number of exceedances since 2004.

More than 80-percent of the smog forming air pollutants come from mobile sources such as heavy duty trucks, construction equipment, trains, marine vessels, and other types of vehicles. Over the past 40-years, air quality trends have improved in the Basin due to the ongoing implementation of rules and technological advances. However, the past two smog seasons, have been characterized by strong high pressure weather systems over the southwestern United States, increasing the trapping of smog by the inversion layers and increasing the sunlight for photochemical reactions that form ozone in our air.

The smog season officially begins on May 1st of each year—typically the time of year when hot, stagnant days stimulate the formation of ground-level ozone, which results in increased smog levels and unhealthy air quality. Smog season officially ends at the end of October. However, exceedances of the federal ozone standard in recent years can occur as early as February and as late as November.

Please Remember to Check Before You Burn

Check Before You Burn is an annual SCAQMD program to help reduce air pollution during the wintertime months from November through February 28. Stagnant weather conditions during these months can elevate fine particulate pollution to unhealthy levels for South Coast residents. When unhealthy particulate air pollution levels are reached, SCAQMD issues a "no-burn" alert to inform residents that it is not okay to burn wood in fireplaces, outdoor fire pits, and wood stoves.
