# Public Hearings Held on Draft 2012 Air Quality Management Plan

he South Coast Air Quality Management District (SCAQMD) recently hosted four regional public hearings in September seeking public comment on its 2012 Revised Draft Air Quality Management Plan (AQMP).

The AQMP is the agency's blueprint for reaching federally mandated, health-based clean air attainment goals throughout the Southland.

The major goals are to meet the:

- 24-hour PM2.5 (fine particulate) standard by 2014;
- 1-hour ozone standard by 2022, and;
- to specify certain commitments in the 2007 State Implementation Plan (SIP) relative to meeting the 8-hour ozone standard.

Public hearings were held at California State University Los Angeles, Buena Park Community Center, San Bernardino's Norton Regional Events Center, and the Louis Rubidoux Public Library in Riverside. The 2012 AQMP changes include baseline inventory refinements, modified SIP commitments, inter-pollutant flexibility as part of transportation conformity, and shifting NOx RECLAIM to a contingency measure.

On September 28, 2012, staff released the Draft Socioeconomic Report for a 45-day public comment period. Interested parties have until November 12, 2012 to submit comments on both the Draft Socioeconomic Report and the Revised Draft AQMP.

# DOE Awards SCAQMD \$4.1 Million for Zero-Emission Truck Project

S CAQMD was awarded \$4.1 million from the U.S. Department of Energy (DOE) to develop and demonstrate four zero-emission drayage truck technologies to help reduce diesel emissions from goods movement activities. Drayage trucks haul cargo containers short distances, typically from the ports to nearby rail centers or warehouses.

"This award helps us target deployment of cleaner transportation technologies in areas disproportionately impacted by diesel emissions, such as the ports," said William A. Burke. Ed.D, SCAQMD Board Chair.

The four projects will include three types of battery-electric truck demonstrations by Balqon in Harbor City, TransPower in Poway and U.S. Hybrid in Torrance, and as well as one

fuel cell hybrid truck project at Vision Industries in Gardena. A total of 13 trucks will be developed.

Collectively, heavy-duty diesel trucks operating in the Southland emit more than 181 tons of nitrogen oxides and five tons of diesel particulate matter per day. According to SCAQMD's third Multiple Air Toxics Emission Study (MATES III), diesel trucks account for a significant portion of the area's cancer risk, particularly impacting residents living in communities surrounding the area's ports.

# CHECK BEFORE YOU BURN

### Wintertime Air Quality to Benefit from "Check Before You Burn" Program and Gas Fireplace Incentives

As part of the Healthy Hearths™ initiative, SCAQMD has initiated a mandatory "Check Before You Burn" program to help improve wintertime air quality by reducing emissions from wood burning in fireplaces.

From November 1st through the end of February, SCAQMD will issue mandatory no-burn advisories for areas where fine particulate air pollution is forecast to reach unhealthful levels. Daily forecast information can be found on SCAQMD's "Check Before You Burn" map at www.aqmd.gov/healthyhearths/checkbeforeyouburn.htm, by phone at (866) 966-3293, and via e-mail for those that sign up for Air Alerts at www.aqmd.enviroflash.info.

Wood smoke contains gases and tiny particles known as fine particulates (PM2.5) that lodge deep in the lungs, reduce lung function, cause chronic bronchitis and potentially cause premature death. Wood burning creates approximately 5.5 tons of PM2.5 emissions per day in the Southland, which is four times the amount of PM2.5 emitted from all power plants in the area.



In addition, SCAQMD's Governing Board recently approved funding for incentives to reduce the cost of purchasing and installing gas log sets or gas stoves (which have lower emissions than their wood-

burning counterparts). Under the program, Southland residents (except individuals living in the mountain communities) can receive up to a \$200 discount to replace existing wood-burning fireplaces or stoves with gas models.

# New Websites Provide Cash Incentives to Scrap High-Polluting Vehicles

outhern California drivers hoping to upgrade to cleaner vehicles now have a helping hand, thanks to two new programs aimed at improving the air quality while reducing the number of high-polluting vehicles on the road.

SCAQMD, in conjunction with the Foundation for California Community Colleges, has launched two new websites to make it easier for consumers to learn about cash incentives to scrap their current vehicle and replace it with a newer, more fuel-efficient one.

The websites for the Enhanced Fleet Modernization Program (at *vehicleretirement.org*) and the High Emitter Replace or Scrap 2 (HEROS2) program (at *heros2.org*) enable vehicle owners to apply online, locate Gold Shield Smog Check stations, and find dealers and dismantlers in the region.

Owners of eligible vehicles will be given cash incentives, ranging from \$1,000 to \$4,000, to scrap their polluting vehicles, and replacement vouchers to upgrade to newer and cleaner models.

Of all of the light- and medium-duty vehicles on the road, approximately 10 percent are responsible for nearly half of all emissions for that vehicle category, according to several studies.

This program is a win-win for both Southern California motorists who want to upgrade to newer, cleaner vehicles, and South Coast Air Basin residents who will breathe cleaner air.

### **SCAQMD Responds to Williams Wildfire**

n Saturday, September 2nd, the Williams Wildfire broke out and burned 4,200 acres in the San Gabriel Canyon. Fire crews battled the fire for hours as hazardous smoke filled the surrounding area. After SCAQMD became aware of the fire, it published a smoke advisory on its website, provided updates on the status of the fire, potential areas of smoke impact, tips on reducing smoke inhalation, and web links for additional information.

Each of these efforts helped inform the public and the media on the location of the impacted areas and informed individuals on how to protect themselves. SCAQMD deployed three portable monitors (called E-BAMs) to measure the particulate concentrations in areas predicted to be impacted by the fire. The monitors continuously tracked particulate matter concentrations until the fire was contained and pollution levels returned to normal.

## Symposium Explores Impacts of Hydraulic Fracturing

n Tuesday, September 18th, SCAQMD hosted a symposium regarding hydraulic fracturing (or "fracking"), a method of extracting oil and gas from new and existing well sites by pumping water, sand, and chemicals into the earth. The symposium was held in response to concerns about the impacts of fracking on the region's environment.

Panelists gave an overview on the use of hydraulic fracturing, and discussed potential environmental impacts and current activities at the federal, state and local levels. An audience of 170 people heard from representatives from government, industry, academia and the environmental community.

The day-long symposium began with opening remarks from Dr. William A. Burke, SCAQMD Governing Board Chair. An overview of the hydraulic fracturing process and geological makeup of the Monterey shale formation followed. It was pointed out that new wells in California are generally for oil production and some associated gas production.

The morning sessions focused on understanding and addressing the impacts of hydraulic fracturing and impacts on the environment. Presentations touched on chemicals used in the process, seismic impacts, and air quality-related health impacts. Possible policy solutions were discussed at the afternoon roundtable which featured representatives from various stakeholder organizations.

> Following the symposium, at its October 6th meeting, the SCAQMD Governing Board directed staff to initiate the development of a rule to report the chemicals used in the fracturing process as well as other provisions that will ensure that air emission impacts are minimized.

### S. Roy Wilson Memorial Award for Leadership in Government **U.S. Representative Jerry Lewis** Congressional District 41, Inland Empire

Congressman Jerry Lewis is retiring this year after serving 17 terms in Congress and a decade in the state Assembly. While in the Assembly, he authored

the legislation in 1977 that established the South Coast Air Quality Management District. That law made history in the regional coordination of air quality planning and enforcement, beginning a path for Southern California to make meaningful progress against smog. Congressman Lewis is credited with focusing on transportation emissions as the largest source of urban air pollution and one with the most cost-effective reductions available. As member and chair of the Appropriations Committee, he secured bi-partisan funding of key projects ranging from the Alameda Corridor, U.S. EPA's air pollutant monitoring program, and incentives for alternative fuel vehicles.



Robert M Zweig, M.D. Memorial Award John R. Balmes, M.D. Physician Member, California Air Resources


Dr. Balmes is a Professor of Medicine at the University of California, San Francisco where he is Chief of the

Division of Occupational and Environmental Medicine at San Francisco General Hospital, and Director of the Human Exposure Laboratory (HEL) of the Lung Biology Center. He leads the HEL's research on respiratory effects of ambient air pollutants, conducting controlled studies on acute effects. Dr. Balmes is also Professor of Environmental Health Sciences at the University of California, Berkeley where he directs the Center for Environmental Public Health Tracking. At UC Berkeley, he collaborates in epidemiological studies on the chronic effects of air pollutants, including the effects of ozone on persons with asthma, and respiratory effects of inhaled particulate matter.



### **Model Community Achievement Award** City of San Juan Capistrano 'Go Green SJC!' Program

The City of San Juan Capistrano, in southern Orange County, developed its 'Go Green SJC!' program as a multifaceted approach to hands-on waste reduction and pollution prevention efforts. Encompassing information and services at both the household and community levels, the program allows residents, community-based groups, businesses, schools and other institutions to understand how daily choices on everything from foodstuffs to energy can affect the larger community. For example, its Green Home Program sets out detailed, voluntary criteria for building or remodeling residences to become 'Green Certified," by implementing such choices as recycled construction & demolition waste, solar panels, energy efficiency systems, and low-VOC paints.





City of Yucaipa Community-wide Sustainability Planning

The City of Yucaipa in San Bernardino County has a population of 52,000 residents, which represents an increase of 25% over the past decade. Yucaipa's focus has been to construct 'backbone' infrastructure necessary to fulfill business-friendly standards and

public wellness as the area continues to transition to suburban development. The city's impressive combination of commitment and results led to Yucaipa being named as a finalist in the 2011 National Civic League's All America City competition, recognizing exemplary grassroots community problem-solving through collaboration.





### **Innovative Transportation Projects Award**

### **ICO Real Estate Group**

Development and Sale of the First Privately Owned, Publicly Accessible DC Fast-Charger Station in the U.S.

Developer ICO Real Estate Group completed the first U.S. development and sale of a commercial property with a privately owned, publicly accessible electric vehicle fast-charge station. The Ree-Charge 'N Go 'non-gas station,' located on North Sierra Street in the City of San Bernardino, is home to retail lessees 7-Eleven and T-Mobile, and includes a multi-car recharging island with an Eaton Direct Current Quick Charger (top-off charge 10 minutes or under, 80% capacity charge under 30 minutes). Jian Torkan, ICO partner, notes that the charger station was seen as an environmental plus in local permitting of the fully-leased retail center.



### **South Bay Cities Council of Governments**

Local Use Vehicle (LUV) Pilot Demonstration Project



The innovative Local Use Vehicle (LUV) project carried out by the South Bay Cities Council of Governments

(SBCCOG) entails a pilot fleet of 100% electric, zero-emission LUVs that are compact, short-range, and low-speed - - and showcases their usefulness for local trips around South Bay neighborhoods and shopping districts. This is the first 'neighborhood electric vehicle' demonstration made available to the general public, and the only such project in the U.S. to use GPS to track usage. The resulting data is publicly available to inform local policy and land use decisions, vehicle purchase decisions, and design issues of manufacturers.



### **Waste Management**

Deployment of 1,000th Natural Gas Solid Waste Collection Vehicle

Over the past two decades, Waste Management (WM) has served as an alternative fuel pioneer, paving the

way toward a new era of low-emission public work operations as they serve more than 20 million residential, industrial, municipal, and commercial customers. During the past year, WM achieved a significant clean air milestone as they deployed the 1,000th natural gas truck in their heavy-duty fleet. In addition, they also constructed dozens of compressed natural gas (CNG) and liquefied natural gas (LNG) fueling stations. WM is also working on projects to produce renewable natural gas for its fleet from the solid waste that it collects.



### **Promotion of Good Environmental Stewardship Award**

**Enterprise Holdings** 

Commitment to Sustainable **Transportation** 

Enterprise Holdings is the parent company of Enterprise Rent-A-Car, the largest rental car company in the United States. Recently, Enterprise has focused considerable effort on bringing rental electric vehicles (EVs) to Southern California, and now offers more than 50 rental EVs at 12 locations in greater Los Angeles, along with related charging infrastructure. Enterprise has also partnered with South Bay Cities Council of Governments and the City of Torrance in a local-use vehicle (LUV) pilot effort, offering EV owners a 15% discount on rental of a longer-range vehicle, along with free charging of their shorter-range battery EV.



### **Inland Empire Utilities** Agency (IEUA)

Portfolio of Sustainable Practices

The Inland Empire Utilities Agency (IEUA) is a municipal water district serving seven cities in western San Bernardino County, which supplies imported and recycled water, and collects, treats, and

disposes of wastewater. IEUA has shown leadership performing these services in a sustainable manner. Components of IEUA's portfolio of sustainable practices include the startup of the first utility-scale wind turbine on-site at a major facility in San Bernardino County, and startup of the world's largest fuel cell operating on digester gas, used for wastewater treatment processes.



### **Public Education on Air Quality Issues Award** Maroon 5

Educating Fans on Environmental Issues

Maroon 5 is an award-winning pop rock band based in Los Angeles, whose members share a strong interest in environmental causes. Featuring lead vocalist Adam Levine, lead guitarist James Valentine, bass guitarist Mickey Madden, and drummer Matt Flynn, the band is an active member of the Green Music Group (sponsored by the non-profit organization Reverb), a large-scale coalition of music professionals and fans who seek to join their collective energies to stimulate positive environmental progress. On national and international music tours Maroon 5 includes such 'greening' elements as 'ecovillage' environmental displays and fan-engagement activities, carbon offset opportunities, Jumbotron eco-slideshows, and ecofriendly event management.

# Hollywood Celebrities Promote Tips for Clean Air Living



A new SCAQMD-produced video features noted film and TV stars explaining how residents can help clean the air. "Tips on Clean Air Living," includes interviews with ten celebrities presenting simple steps that individuals can take at home and on the road to help improve air quality.

"Southland residents can play a vital role helping to reduce air pollution," said William Burke, Ed.D., SCAQMD Governing Board Chairman. "We are going to need all 16 million residents to do their part in reducing emissions to reach our goal of clean air."

The eight-minute video, available for viewing at www.cleanairchoices.org, premiered Oct. 12, at AQMD's 24th annual Clean Air Awards at the Millennium Biltmore Hotel in Los Angeles.

The video features Law and Order's Elisabeth Röhm introducing the video, and follows with tips from Wendie Malick of TV's Hot in Cleveland; Ed Begley Jr., known for his roles in the TV series St. Elsewhere, Arrested Development, and Six Feet Under; Sharon Lawrence and Esai Manuel Morales, both of TV's NYPD Blue; Paul Reiser from the TV sitcom Mad About You; Daphne Zuniga, who appeared in TV's *Melrose Place* and *One* 

Tree Hill; Baywatch star and electric vehicle activist Alexandra Paul; Jamie Durie of HGTV's The Outdoor Room and PBS's The Victory Garden, and Donna Mills, famous for her role in the TV series *Knots Landing* (joined by her daughter Chloe Mills, president of the Green Youth Movement organization).

In the video, the celebrities offer a variety of clean air tips such as how planting trees can shade a home and reduce cooling costs, the health impacts of smoke from wildfires, the benefits of using house paints that contain no or very low amounts of smog-forming volatile organic compounds, and how purchasing a low-emitting, fuel-efficient vehicle can save money on fuel and help clean the air.


