## **Purpose of the Meeting**

The South Coast Air Quality Management District (AQMD) has scheduled a Public Workshop and CEQA Scoping Session to present and solicit information and suggestions from the public regarding **Proposed Amended Rule (PAR) 1138** – **Control of Emissions from Restaurant Operations**. The proposed amendments implement Control Measure BCM-05 of the 2007 AQMP and add requirements for some under-fired charbroilers. The proposed amendments are scheduled for a January 8, 2010 Public Hearing.

### **Air Quality Objective**

PAR 1138 is proposed pursuant to the 2007 AQMP and under California Health and Safety Code Section 39614(d)(1), as a feasible measure, following the adoption of a rule requiring controls for under-fired charbroilers by Bay Area AQMD and a similar proposal by the San Joaquin Valley Unified Air Pollution Control District. The objective of PAR 1138 is to improve public health exposure through the reduction of PM<sub>2.5</sub> emissions and contribute towards the attainment of the State and federal particulate matter standards. PAR 1138 is estimated to reduce 2.1 tons/day of PM<sub>2.5</sub> emissions by 2014.

#### **Summary of Proposed Amendments**

The proposed amendments are as follows:

- Add one definition, "beef";
- Add provisions for under-fired charbroilers cooking greater than or equal to 1,250 lbs of beef/week to employ the use of an add-on air pollution control device, by specific dates, achieving an overall minimum control efficiency of 85%;
- Provide for exemptions with associated recordkeeping requirements; and
- Add a testing protocol for under-fired charbroilers.
